DEVELOPING LEADERSHIP: TRANS-FORMING HEALTH CARE

Leadership may be a quality that's most often associated with executive offices, but IHPME's Tina Smith, who leads the Institute's MHSc accreditation program, believes the health system of 2015 and beyond needs leaders at every level of an organization.

IHPME's MHSc Health Administration program is designed to meet this need through its focus on the unique leadership challenges facing the health care sector. "Students experience a classroom environment that includes a diverse mix of students from different professions and career stages," says Tina. "An inter-disciplinary curriculum brings together business, management and policy to broaden their exposure to current trends and directions in health care."

In November 2014, the program received a maximum seven year accreditation award for program excellence from the Commission on Accreditation of Healthcare Management Education.

Built around the NCHL Leadership Competency Model™, the program's curriculum focuses on three overarching domains – Transformation, Execution and People. Within those domains are 26 behavioral and technical competencies, which managers and professionals can use to assess their progress as leaders. "The program is based on the fundamental premise that leadership development is an ongoing process that takes deliberate practice," says Tina. About two-thirds of the assignments are field-based, and all in-class learning and other assessment activities are designed to simulate real-world activities.



Because the curriculum focuses on leadership attributes, the program seeks applicants with more intangible qualities. The selection process uses competency-based approaches meant to identify personal attributes,

Applicants are reviewed and ranked, with one-third going through to an interview process. Once there, they move briskly throughout a series of three interview stations, each with two program faculty and one current student. It's an opportunity for the applicant's leadership potential to shine through – interviewers have no knowledge of grades, references or letters of intent. The program's admission committee makes the final assessment.

Part of the program's attraction for many students is that they can continue in their careers while still completing the MHSc program in two years. Class time is concentrated into Wednesday evening, all day Thursday, Friday and Saturday. These sessions happen five times in a four-month block.

"Classmates and guest faculty provide a strong network of colleagues and employers that extends well beyond their time in the program," says Tina. Students are likely to be sitting among – and sharing ideas with – nurses, physicians, rehabilitation therapists, accountants, lawyers, pharmacists, social workers and engineers. After finishing the program, graduates have gained a network of people who work in government, planning agencies, acute care, rehabilitation, mental health, community care, primary-care, long-term care, as well as voluntary agencies, consulting and industry.

While education is an essential step toward a leadership career

in health care organizations, IHPME's MHSc Health Administration graduates leave the program equipped with the tools to continue their leadership journey, progressing over time to senior leadership positions throughout the health care delivery system.

"Our graduates gain a perspective that spans the entire health care sector. The experience resonates throughout their careers," says Tina. "I'd describe the student experience, in one word, as 'opportunity."

OBSERVATIONS FROM A MASTERS STUDENT

RELATIONSHIPS RESPECT DISCIPLINE: WHAT IT MEANS TO TRULY CARE FOR PATIENTS

Andy Geer is a Master of Health Administration student at the University of Toronto's Institute of Health Policy, Management and Evaluation. Previously, he worked for St. Michael's Hospital in the Decision Support department and will begin working at the OHA in January. Andy came to Bridgepoint in the fall of 2014 for his practicum and we asked him to reflect on his time here.

One cold evening last winter I hurried into class a few minutes late to find that we had a guest lecturer in the midst of a presentation. As she walked up and down the aisle, I realized that her smaller stature belied a very passionate, seemingly inexhaustible enthusiasm — an enthusiasm that captivated the class for an entire hour. At the start of Marian's presentation, I knew little about the organization or its leadership, but by the end, Bridgepoint was the only organization I wanted work on my practicum with.

Arriving at any new organization is challenging – getting to know the people, understanding its business, and figuring out how you can contribute – but even more so when this needs to be accomplished within three months. However, the warmth and willingness of staff across the organization to meet with me and share their stories and the work that they do has made my experience here an incredible one.

A unique project that stands out in my mind is the admission redesign project that uses experience-based co-design to



improve the patient experience during the first 48 hours after admission, recognizing that patients also play an important role in process improvement. Essentially, it is a way of gathering the negative and positive experiences of both staff and patients, and then bringing them together to explore the findings to identify ways to improve service. During the value stream mapping exercise, I was impressed by the enthusiasm and teamwork of the 2 North staff, where we discovered a number of areas where staff were going beyond their prescribed duties to increase the comfort and experience of patients.

From my involvement in this project, to the Board meetings discussing hospital strategy and operations, I have been afforded a unique opportunity to observe the entire organization at work and how it deals with the complex and dynamic nature of the health care sector.

During my time here, I have also had the opportunity to observe the leadership and care for patients that permeate every level of the organization. Each member of staff knows the role they play in achieving Bridgepoint's vision, and it's inspiring to watch how closely aligned the organization's efforts are with its strategy.

I have learned many things over the last few months that will serve me well far into my future. I have a new appreciation for the value of relationships, respect, discipline and what it means to truly care for patients that face complex challenges I little understood before. I leave Bridgepoint with a newfound respect for the front-line clinicians that do this daunting job every day, and with great appreciation for what it takes to provide the leadership that makes this possible.
